1. Introduction

The European Union Common Criteria Information Sharing and Analysis Centre (EUCC ISAC AISBL) is a non-profit international association established under Belgian law. Membership fees contribute to the operational sustainability of the Association, the development of joint activities, and the effective functionning to the Technical Groups.

2. Categories of fee-paying members

The following type of members (also designated as private organisations) can join the EUCC ISAC as paying members:

- Private Conformity Assessment Bodies (CABs)
- Industry, Labs, ITSEFs and Other Stakeholders

3. Categories of de-facto Members

The following type of members (also designated as "public autorities") are considered *de facto* members, free of charge:

- National Certification Authorities (NCCAs)
- Conformity Assessment Bodies (CABs) as part of an NCCA

4. Determination of Membership Fees

Membership fees are determined based on the following criteria:

A. Basic Membership Fee

A basic annual fee is applied to each member of EUCC ISAC. This ensures coverage of the general administrative and coordination costs of the Association.

B. Technical Group Participation

In addition to the basic fee, members contribute to the costs of each Technical Group in which they participate.

- Each Technical Group proposes a dedicated fee contribution calculated according to its operational needs.
- These estimates are validated by the Steering Committee and subsequently adopted as part of the annual budget prepared by the Bord of Directors and approved by the General Assembly.

C. Annual Revenue Range

Both the basic fee and the technical group fees may be scaled according to the total **global annual turnover** of the corporate group the member belongs to. For these purposes, a "corporate group" means the member and any entities under common control, directly or indirectly.

D. Eurosmart Membership Status

Applicants who are members of Eurosmart benefit from discounted fees during the first year of membership. This discount may be reconducted subject to decision of the General Assembly.



5. Invoicing and Payment Terms

- A **single consolidated invoice** that includes Member's participation in the slectected Technical group is issued annually by the EUCC ISAC Secretariat.
- Membership fees must be paid within 90 calendar days of invoice issuance in order to maintain active membership status.
- If membership begins mid-year, a **pro-rata fee** will apply. *Pro-rata fee* = (Annual fee ÷ 12) × number of months remaining")
- Membership fees are **reviewed annually** by the EUCC ISAC General Assembly, upon proposals made by the technical groups, and may be adjusted accordingly.

6. Transitional Arrangements for 2025

- For the year 2025, historic members will only be charged for the last quarter (October– December 2025). The applicable pro-rata fee will cover a 3-month period, starting on 1 October 2025.
- To anticipate the 2026 membership cycle, members will receive a quote during the last quarter of 2025. This quote will enable those who require a purchase order (PO) update to proceed in advance.
- The official invoice for the 2026 membership fee will be issued during the first week of January 2026.
- The General Assembly, to be organised 2026, will deliberate on the annual budget, budget based on the Technical Groups' budget proposal and the EUCC ISAC budget prepared by the Board of Directors.

8. Example of Membership Fee Calculation (2025)

Case:

- Company beloging to a Group whose global annual revenue = €40M
- Participates in ISAC membership (by default) + JHAS + ISCI
- Not a Eurosmart member
- Applying in September

Step 1 – Base ISAC Membership Fee

Revenue range: **5–50M** → €3,200

Step 2 - JHAS Participation Fee

Revenue range: **5–50M** → €700

Step 3 – ISCI Participation Fee

Revenue range: **5–50M** → €60

Total Annual Fee =

€3,200 + €700 + €60 **= €3,960**

Pro-rata temporis

Membership starts in **October** → 3 months (Sept–Dec) out of 12.

Calculation: €3,960 × (3 ÷ 12) = **€990**
